3. **Subject of the competition:** for the right to conclude EPC – contract for the construction of a thermal power plant with an installed capacity of 1200 MW (stage 1 2x300 MW; stage 2 1x600 MW) in the Naryn region of the Kyrgyz Republic with the supply of power to the 500 kV energy system of Kyrgyzstan.
Subject of the EPC contract:
Execution of works on:
 - design, supply of equipment and construction of the Kara-Kechin thermal power plant (TPP) with an installed capacity of 1200 MW in two stages of commissioning (stage 1 - 2x300 MW), (stage 2 - 1x600 MW) with the output of power into the 500 kV power system of the Kyrgyz Republic;**Scope of work performed:**
 - 1) For the 1st stage of 2x300 MW construction of the Kara-Kechinskaya TPP with the "Technical part" section of the Tender documentation.
 - 2) For the 2nd stage of 1x600 MW construction of the Kara-Kechin TPP, volumes according to the developed design documentation.A detailed description and requirements for the work to be performed, as well as the terms of the EPC contracts, are contained in the Tender Documentation.
4. **Place of work:** in accordance with the Tender Documentation. Information on
5. the maximum (limit) price of the EPC contract must be calculated taking into account all taxes, fees and other mandatory payments provided for by the legislation of the Kyrgyz Republic.
 - For construction The estimated cost of the 1st stage of the 2x300 MW Kara-Kechin TPP is 934.38 million US dollars.
 - Construction cost The 2nd stage of 1x600 MW Kara-Kechin TPP is approximately 370.6 million US dollars, due to the readiness of some facilities after the construction of the 1st stage.
6. **Guarantee of order fulfillment:** provided in the amount 1% of the contract amount in the form of a bank guarantee.
7. **Contract performance guarantee:** provided in the amount 5% of the contract amount in the form of a bank guarantee.
8. **Deadline, place and procedure for submitting tender documentation:**
The tender documentation is publicly available on the website of the Ministry of Energy of the Kyrgyz Republic www.minenergo.gov.kg , JSC "Electric Stations" www.energo-es.kg.
The notice of the open competition will be posted «03» June 2025
Tender documentation can be provided in **paper form**, to a person on the basis of his **written request** to receive tender documentation,

submitted in the original.

There is no fee for providing tender documentation. **Deadline for submission of tender documentation:**

The tender documentation shall be provided within 2 (two) working days from the moment the Organizer of the tender receives the corresponding written request.

9. **Place of submission and deadline for submission of applications for participation in the competition:** Applications for participation in the competition must be submitted **to 10:00 (Kara-Kul time) August 5, 2025** at the address: Jalalabad region, the city of Kara-Kul, Lenin street 48.
10. **Date and place of consideration of applications for participation in the competition:**
The competition organizer will conduct a public opening of envelopes with applications for participation in the competition. **At 12:00 (Kara-Kul time) August 6, 2025** at the address: Jalalabad region, Kara-Kul city, Lenin street 48. **Date and place of summing up the results of the competition:** The results will be summed up on to the address of the Customer of the competition no later than **«06» October 2025**. The organizer of the competition has the right, if necessary, to change this term. The contract based on the results of the competition between the Customer and the Winner of the competition will be concluded no later than 20 (twenty) days from the date of signing the protocol on the results of the competition.
